With the move to new offices coming up, now is the time to plan to accommodate these facilities in our new offices.

The current MAV Rules were not written to facilitate virtual meetings. Last year saw the cancellation of our 2 scheduled State Council meetings, the Annual Conference and the Regional and Metro forums.

The MAV Rules are overdue for revision and need to be re-written to match the expectations of our membership.

I'm now in my 5th year as a MAV Rep and as the current Board member for the Eastern Metro Region, have greatly benefited from the regular meetings that bring our regional Rep's, Mayors and CEO's together to discuss the issues that matter in the Region.

As President I would encourage a similar model across all 12 Regions and I commit to travel to all of your Region's scheduled meetings, wherever in the State that they made be held.

Council finances have been smashed by the impacts of Covid-19 with income dropping across the board while expenses have risen way beyond our prepared budgets.

With rate capping seemingly here to stay our sector needs to advocate for solutions to fill this revenue gap with the State through either one off, or ongoing programs to repair the financial positions of all Councils. Local Government also needs to work harder on improving our reputation with our residents and ratepayers across the State. We need to promote the public good that we do to get this message across.

As the level of government closest to the people we need to build on our relationship with both State and Federal governments by stepping up our sector advocacy and policy output so that we are proactive in championing our communities' needs.

A good working relationship with the State is vital to achieving this and my former occupation as an MP helps bring the contacts and networks that are needed to succeed in our advocacy.

By working together with all parties we can achieve better results for our communities.

If elected, I will work as your full time President, visiting every Council in the Eastern Metro Region at mutually convenient times, to see and hear first-hand the successes that you have achieved and the problems that need to be addressed.

As President, I will be here for you and will always listen and take genuine account of your Council's views and concerns.
